I am writing to express my concerns as a licensed private hire driver under Huntingdonshire District Council. The cost of obtaining and maintaining a private hire licence with your council is significantly higher compared to neighbouring councils such as Peterborough, Bedford, and South Cambridgeshire. However, despite the high costs, your licence is not accepted by major platforms such as Uber, Bolt, or Veezu, which limits our ability to work and earn a reasonable income. Additionally, the recent push to require CCTV installation in all licensed vehicles adds another financial burden on drivers. While safety is important, such requirements should come with proper financial support or subsidy, especially when most drivers are self-employed and already struggle with fuel, insurance, and licensing costs. Due to these factors, many drivers are choosing to move their licences to other councils where: - The application is cheaper and faster. - The licence is accepted by all major ride-hailing platforms. - There is no forced CCTV installation unless justified. I respectfully urge the council to review: - The overall cost structure of the PHV licensing system. - The CCTV requirement policy. - Possibilities to integrate with platforms like Uber and Bolt to support drivers better. Without improvements, Huntingdonshire may lose more driver. Why doesn't Huntingdonshire Council allow private hire drivers to work with Uber, Bolt, or other major platforms like other councils do?

Why are drivers being restricted and forced into unnecessary bureaucracy and high costs, including expensive CCTV systems?

Instead of helping drivers earn a living, the system is making it harder. Many of us are considering leaving for other councils where we can actually work freely.

Please reconsider your policies before more drivers walk away

To make matters worse, the cost of remaining roadworthy continues to climb—insurance, road tax, and MOT fees have all gone up. Adams, the MOT garage designated by the council, is now also asking us to pay for a second MOT, which is effectively identical to the taxi MOT. It uses the same data and checks, yet he's profiting from this by charging every driver again for something that's already been covered.

These are just a few of the many ongoing issues we're facing. In light of this, I simply cannot afford the added financial burden of installing CCTV. I urge you to focus on addressing these existing concerns rather than imposing further costs on drivers who are already struggling.

I don't understand why Huntingdonshire council is pushing to install CCTV in the taxis. When they are not doing anything about the cross boarding. We have barely any work left on the rank as it is. UBER is killing the market. Peterborough taxis are not required to have a CCTV in their taxis and they are working in Huntingdonshire. So I thinks it's just waist of taxis drivers time and money which they can't afford as it is.

I am writing in response to the current consultation on the proposal to mandate the installation of CCTV systems in all licensed taxis and private hire vehicles operating in the Huntingdonshire district.

While the intention to enhance public safety and driver protection is appreciated, I wish to express serious concerns regarding the necessity, effectiveness, and financial impact of such a policy.

#### 1. Lack of Clear Evidence on Crime Reduction

There is no conclusive evidence from other local authorities that mandating CCTV in taxis has led to a significant reduction in crime or anti-social behaviour. For example:

Oxford City Council, which implemented mandatory CCTV in taxis in 2015, later faced legal challenges over data protection concerns, and there was no publicly shared data confirming that the presence of CCTV resulted in measurable reductions in incidents.

Southampton City Council, after introducing compulsory CCTV, admitted that while CCTV helped in some investigations, it did not act as a major deterrent nor substantially reduce crime rates.

A Department for Transport (DfT)-commissioned review in 2020 acknowledged that while CCTV may help in investigations, it does not guarantee prevention, and excessive use may raise privacy and data protection concerns, especially under GDPR and UK data laws.

#### 2. Financial Burden on Drivers and Operators

Many taxi drivers and vehicle owners are already struggling with increasing operational costs—fuel prices, insurance premiums, maintenance, and licensing fees. The mandatory installation and maintenance of CCTV systems, often costing upwards of £500–£1,000 per vehicle, poses an unreasonable financial burden.

This will especially affect small independent operators and part-time drivers, many of whom may be forced out of the trade, leading to reduced transport availability for the local community.

### 3. Privacy and Data Concerns

The mandatory use of CCTV inside vehicles raises complex guestions around data protection, particularly regarding:

I am writing on behalf of Shabab Latif/ Sai Baba Cars Ltd to express serious concerns about the district council's proposal to mandate the installation of CCTV cameras in all locally licensed taxis. While we understand the council's goal of enhancing public safety, this proposal presents significant issues that we believe have not been fully considered.

Our primary concern is the considerable financial burden this would place on local taxi drivers and businesses. The cost of purchasing and installing this equipment would be substantial, and in an industry already facing tight margins, this expense would be devastating. Local taxi businesses are already struggling to compete with larger, cross-border ride-sharing services, such as Uber, which are not subject to the same regulations or expenses.

This leads to our second major point: "fairness and equal application". The proposal states that CCTV would be installed in "every taxi," but this is simply not the case. If this regulation is only applied to taxis licensed within our local district, it will create an unfair and unequal playing field. Drivers from neighbouring districts and services like Uber would continue to operate in our area without being required to install CCTV. This would not only fail to achieve the goal of having CCTV in "every" taxi, but it would also put local, licensed drivers at a significant disadvantage, as they would be the only ones bearing the financial cost and operational changes.

Furthermore, we are deeply concerned about the "privacy implications" for both drivers and passengers. The installation of constant surveillance raises serious questions about data protection, storage, and access. Customers, particularly those using taxis for sensitive or personal reasons, may be uncomfortable with being recorded. This could potentially deter them from using our services.

We urge the council to reconsider this proposal. If the goal is to improve safety through surveillance, then the regulations must be applied consistently to "all" vehicles providing taxi services within the district, including Uber and other cross-border operators. To do anything less would not only be ineffective but also deeply unfair to the local businesses that are the backbone of our community.

We are ready and willing to work with the council to find a solution that addresses safety concerns without disproportionately penalizing local taxi businesses.

Thank you for your time and consideration of this important matter.

It may be ok voluntarily in Hackney Carriages but not in Private Hire as it is an invasion of privacy.

Any imposition of cctv for private hire vehicles would probably lead to the end of the high trust part of the industry. I strongly advocate the use of CCTV in licensed vehicles, both from my operators perspective and as a member of the public. Anything that enhancing safety, accountability, and public confidence is a good thing while protecting the licensed drivers too

However, as an operator under HDC, granted "plate exemption" I beleive CCTV needs to be considered very differently and in line with the current policy exclusions of Plate exemption.

Our clients specifically book us because of the high level of discrete, private and confidential environments we provide in our cars. CCTV would not work or support their travel needs and risk the terms under which they book with us. In fact even our front and rear dash cams, which I believe should be standard on all licensed vehicles, clients regularly raise questions checking to ensure that no audio or conversations inside the car are being recorded. Anything recording in the cars would see many clients not using our services

I do hope that for 'plate exempt' vehicles, CCTV is given careful consideration, as this survey does not appear to address these unique circumstances to which we operate and clients book us for.

As a passenger, I support the use of CCTV cameras inside licensed taxi and private hire vehicles. I believe that CCTV enhances the safety and security of both passengers and drivers by deterring inappropriate behavior and providing valuable evidence if any incidents occur. Ensuring that recordings are handled with respect for privacy and deleted within a reasonable timeframe would help maintain trust and confidence in this safety measure

I respectfully propose the establishment of a mandatory policy requiring that in-vehicle CCTV recordings be securely deleted seven days after the completion of each journey, provided no complaints have been lodged by either the passenger or the driver. This measure would safeguard passenger privacy by ensuring that personal footage is not retained unnecessarily.

Additionally, all drivers should be required to sign a declaration confirming the deletion of such recordings once the retention period has expired without incident. Passengers must be informed that CCTV footage is recorded solely to ensure the safety of both parties and will only be accessed by relevant authorities in the event of a formal complaint.

Beyond the seven-day period, no CCTV footage should be stored or requested. This timeframe is sufficient for addressing any concerns and requesting evidence, thus balancing privacy rights with safety considerations.

Yes, I support the use of CCTV as a safety measure for both drivers and passengers. However, I believe it should be optional rather than mandatory, with clear privacy policies and financial support for installation. Operators and drivers should have the freedom to choose, while ensuring that systems used are secure and compliant with data protection laws.

My opinion on the proposed mandatory installation of CCTV in licensed taxis and private hire vehicles:

I understand and support the intention behind introducing CCTV in licensed taxis and private hire vehicles – particularly in terms of improving safety and accountability. However, I believe that CCTV should not be mandatory, but strongly recommended.

Here's why:

- 1. Privacy concerns Recording in such a confined space raises valid concerns for both drivers and passengers. Footage should only be stored securely, for a limited time, and accessed strictly in the case of an official complaint.
- 2. Financial burden Many drivers may struggle with the cost of installation and maintenance. The Council should consider offering financial support or optional grant schemes.
- 3. Freedom of choice Drivers should have the right to decide whether they want to install CCTV. Passengers can then make informed choices by selecting vehicles with or without CCTV, depending on their preferences.

Taxis and minicabs yes but not Executive PH, plate exempt. I know a lot of my HNW and upper management clients would question the privacy issue as they often hold sensitive phone calls while in my cars. I fear they would stop using my services and I would lose them as clients if I had to have CCTV fitted. In my opinion the services I provide, unlike taxi and minicab companies and the clientele I drive CCTV is not required. Only in taxis and minicabs as explained above.

Times are worrying when compulsory CCTV has to be installed in licensed vehicles where operators and drivers are supposed to have been checked as we all know this is as much as keeping passengers safe from drivers as it is from keeping drivers safe from passengers.

Only if taxi drivers / taxi companies are not forced to install very expensive cctv equipment. passengers do not like to be recorded.

CCTV is good for the safety of driver and passenger. CCTV is there to safeguard those who travel alone and where their journeys are more remote or secluded. It gives security and comfort.

I guess it's a safety v cost issue - it's a brilliant idea for additional safety/protection of both drivers and passengers but the cost would likely be passed on to the consumer in increased fares in an already difficult economic climate.

CCTV being present makes passengers feel safer, also reassured knowing that there is evidence to verify wrongdoing from the driver or indeed fellow passengers

when allegations are made, it provides operators with a means of verifying or dismissing such allegations, and when passengers are abusive, it provides evidence to enhance and encourage police support and action

where CCTV has been mandated, there is always resistance from the trade due to cost, but in reality, they soon realise that the cost of CCTV is cheaper than the cost of legal support when accusations are made, in relation to invasion of privacy, once they realise that the data is only stored within the vehicle, and can only be accessed when an allegation is made, and even then, only accessed directly by calling the vehicle in to examine the footage, such fears are overcome, once implemented and used to protect drivers, the local drivers soon realise they would not want to be with out CCTV in place.
