STANDARDS AND CONDUCT WEB SITE (Report by the Director of Central Services and Monitoring Officer)

1. INTRODUCTION

- 1.1 Members may recall that at their last meeting (Minute No. 9 refers), the Committee considered correspondence received from the Vice-Chairman of a Parish Council in Huntingdonshire which questioned the content of the "Standards and Conduct" pages on the District Council's web site and, in particular, the absence from the web site of the contact details of the non-elected and parish council representatives on the Standards Committee.
- 1.2 The Parish Councillor contended that the details of all Members of a Committee appointed "to promote and maintain high standards of conduct" should be publicly available.
- 1.3 The Chairman has undertaken to convey the Committee's view to the Parish Councillor once a decision has been taken on the matter.

2. INITIAL THOUGHTS

- 2.1 In discussion at their meeting on 6th July 2006, the non-elected Members present, whilst not objecting to their contact details being made available on the web site, questioned the circumstances under which an individual might feel it necessary to contact them and were concerned that, in the event of an investigation, their position might be compromised if they were to receive direct communications from complainants and/or Councillors under investigation.
- 2.2 The Chairman also reiterated his view that the independent members and Parish Councillors appointed to the Committee were not elected District representatives and therefore, served the Committee under different circumstances.
- 2.3 As a way forward, the Committee requested the Deputy Monitoring Officer to review the practices adopted by other authorities in Cambridgeshire and to present a brief résumé of these to their next meeting.
