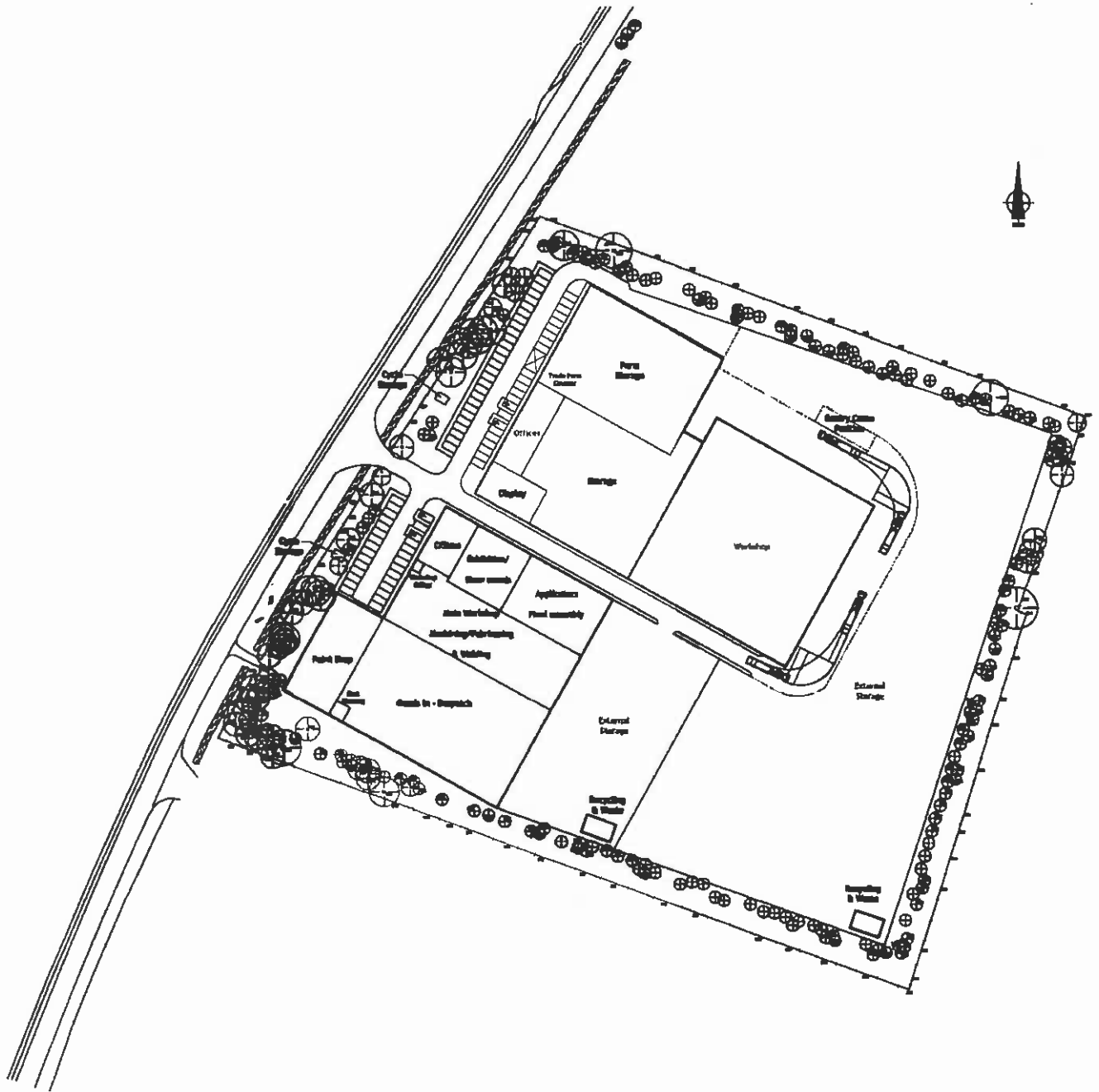

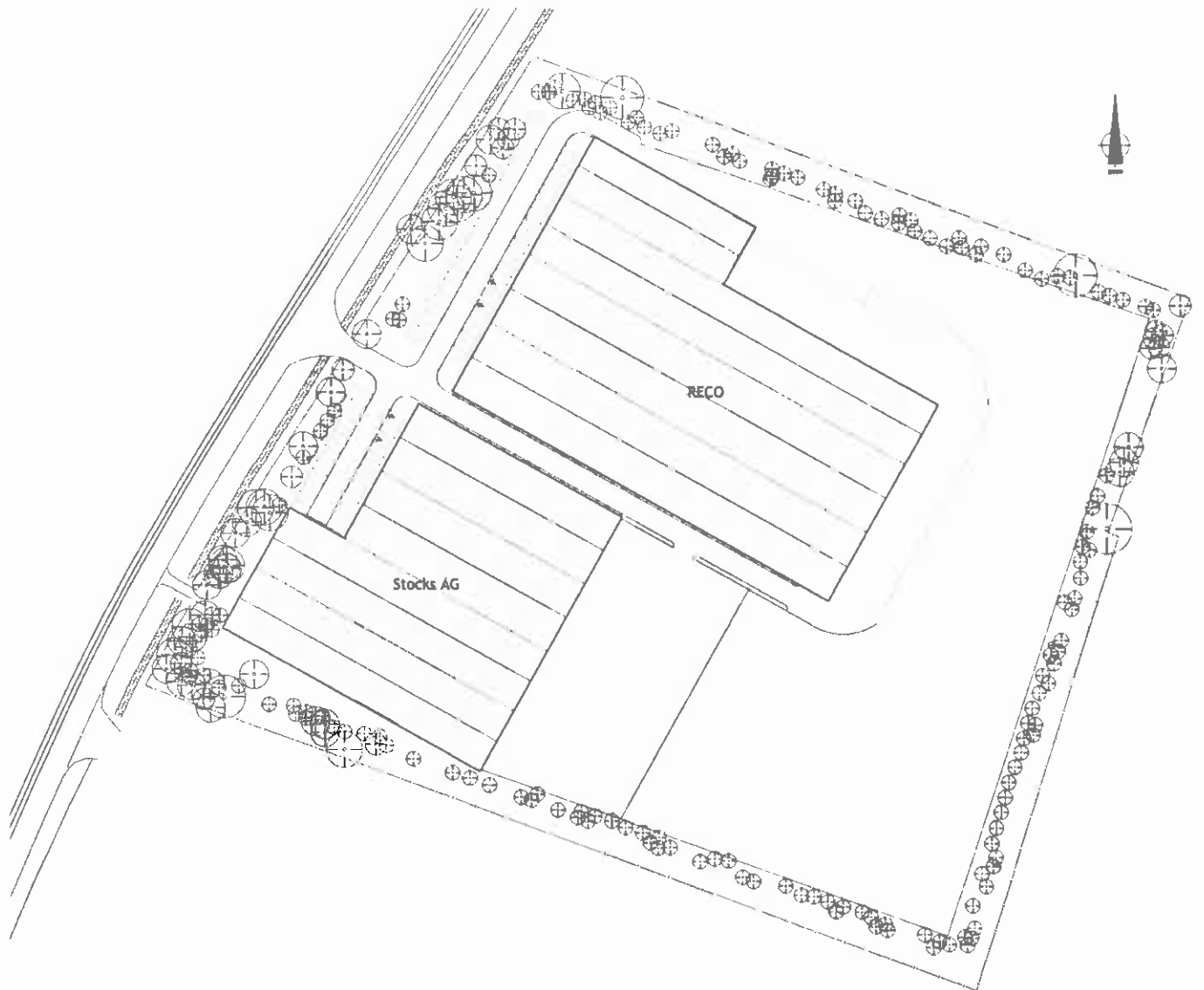

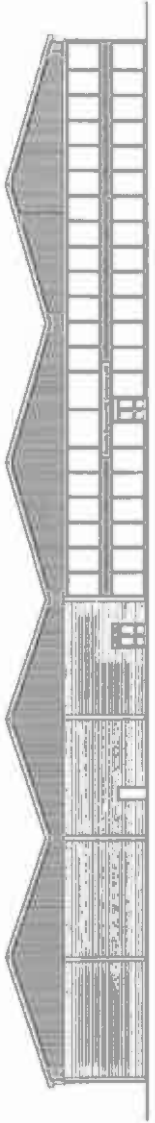

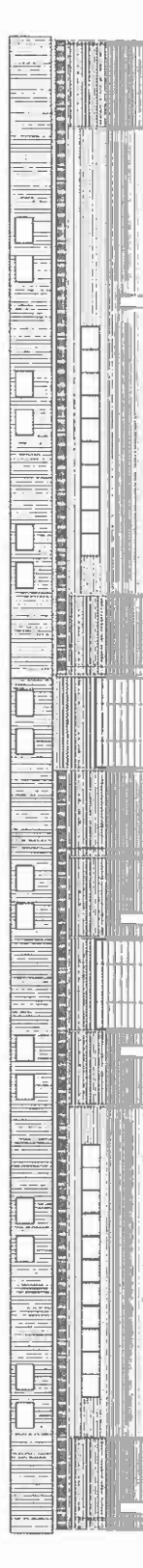
Drawing: RECO Proposed Elevations

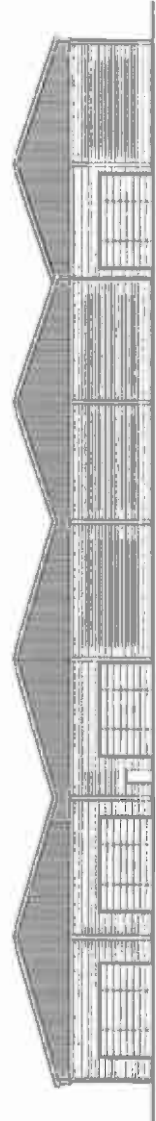
North Western Elevation

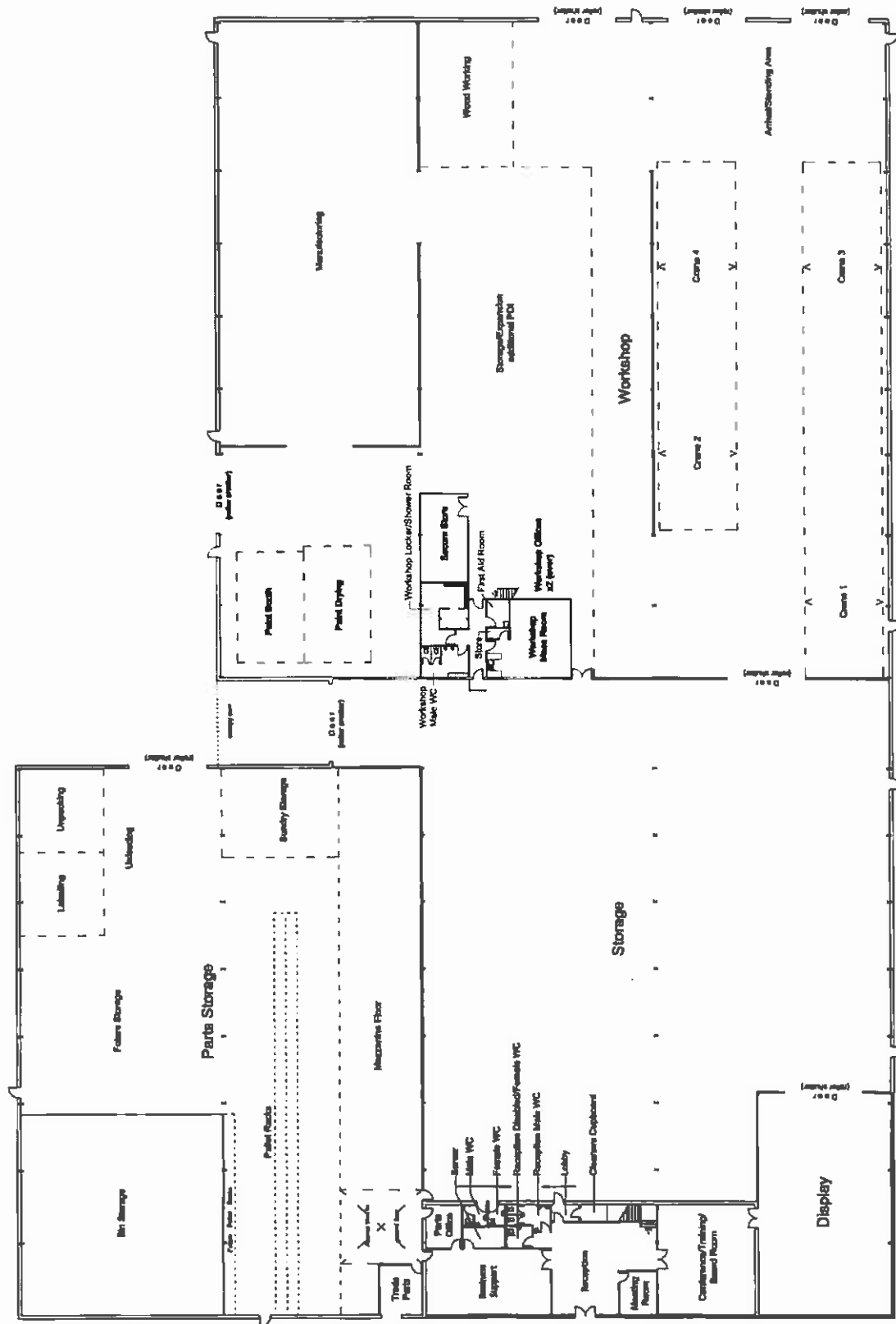

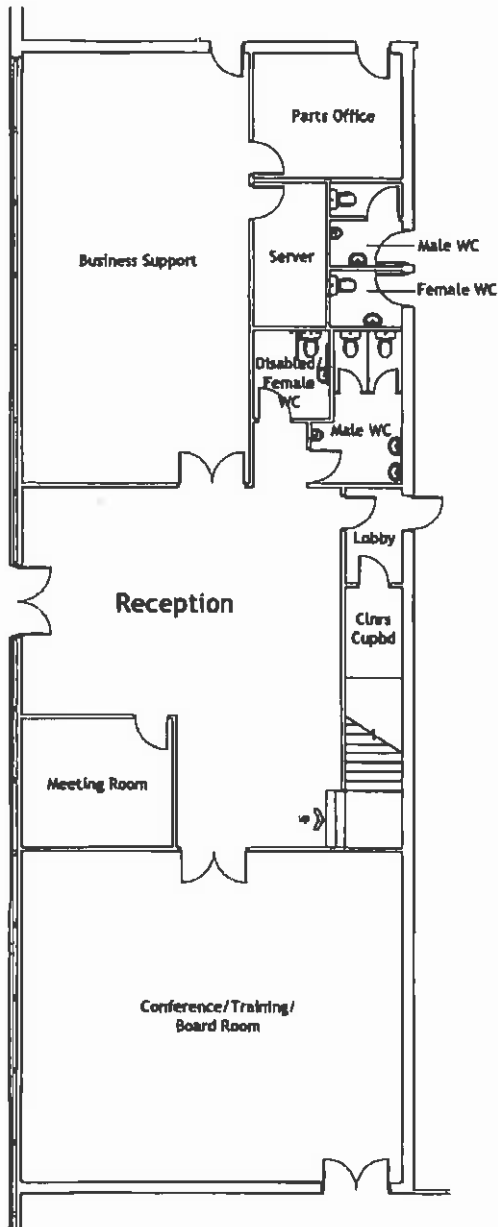
Drawing: RECO Proposed Ground Floor Plan

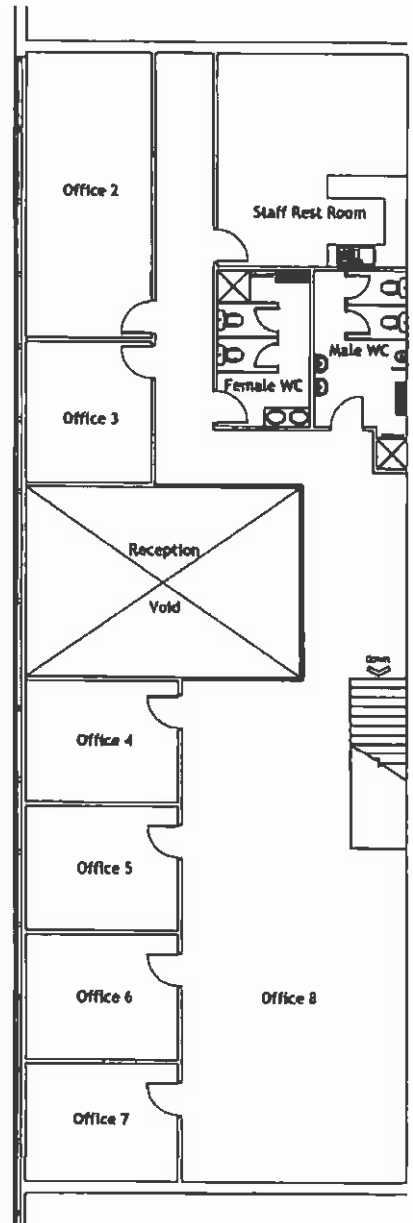

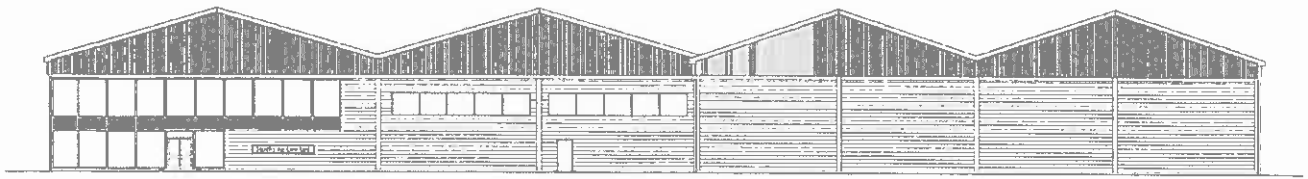

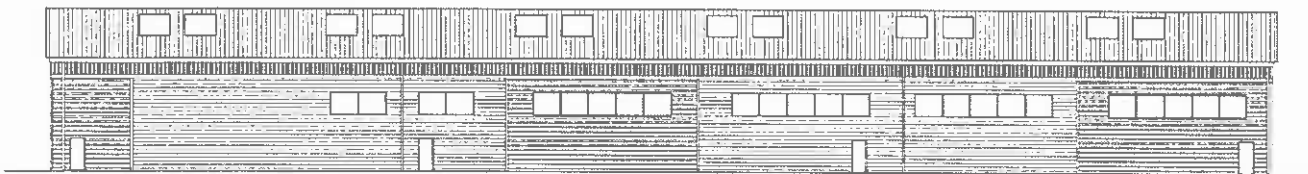

Drawing: Stocks AG Proposed Elevations

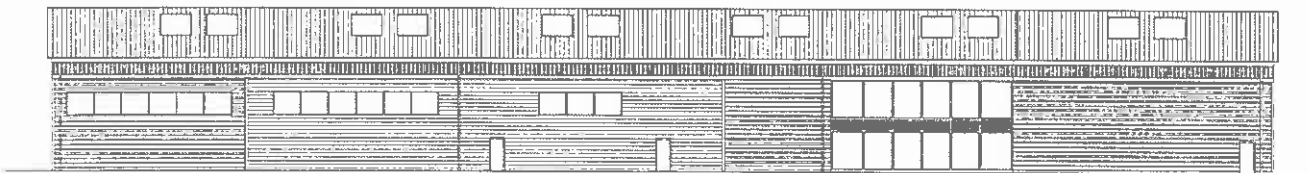

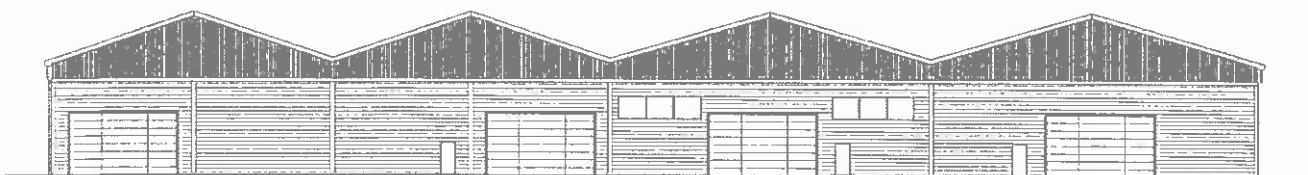
North Western Elevation

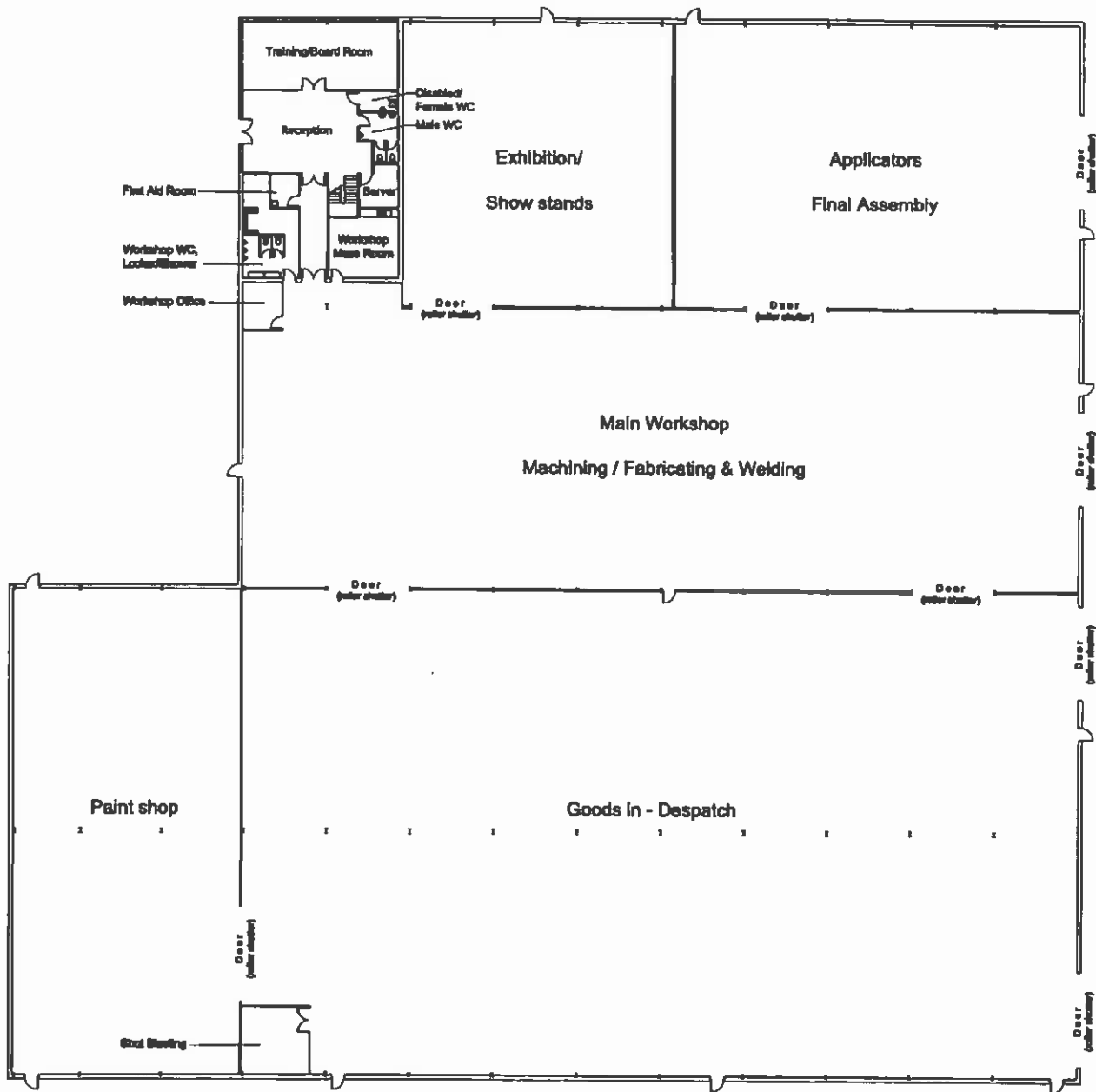
